#### Introduction

This Policy is issued by Omni Sp. z o. o. (LLC) ("Company", "we", "us" and "our"). This Policy may be amended or updated from time to time to reflect changes in our practices with respect to the Processing of Personal Data, or changes in applicable law. #### What are cookies?

Cookies are small text files that may be stored on your computer or other device when you visit a website. They are generally used to make websites work, to keep track of your movements within the website, to remember your login details, and for similar activities. There are different types of cookies and they can be distinguished on the basis of their origin, function and lifespan. Important characteristics of cookies include the following:

- First-party cookies are cookies that are stored by the website you are visiting, while third party cookies are stored by a website other than the one you are visiting. Please note that we do not control the collection or further use of your data by third parties.
- Necessary cookies are necessary to allow the technical operation of a website (e.g., they enable you to move around on a website and to use its features).
- Analytics cookies collect data on the performance of a website such as the number of visitors, the time spent on the website and error messages.
- Performance cookies increase the usability of a website by remembering your choices (e.g., language, region, login, and so on).
- Marketing cookies enable a website to send you personalized advertising.
- Session cookies are temporary cookies that are erased once you close your browser
  while persistent or permanent cookies stay on your device until you manually delete
  them or until your browser deletes them based on the duration period specified in the
  persistent cookie file.
